ELECTRONIC SOURCES [ACCESSED ON THE WEB] {5.6}

In general, follow the format for the *kind* of source and indicate the *medium of publication* you consulted (Web); however, you must also provide additional information to indicate *how* you accessed the source, such as the title of the database or web site, the date on which you accessed the source, and the internet address (URL). [NEW to 7th edition]: Only include the URL as *supplementary information* when a reader probably cannot locate the source without it *or* if your instructor requires it; if the URL is required, give the full URL within angle brackets immediately following the date of access, a period, and a space {5.6.1}. Each electronic source may require slightly different information, depending on the source.
